What is this product?

Type

An English law governed, uncertificated, registered, collateralised exchanged-traded note linked to the Emerging Equities Rolling Futures through swap arrangements ("Swaps") entered into with eligible swap providers ("Swap Providers").

The objective of this product is to provide three times the daily performance of the Emerging Equities Rolling Futures Index (the "Benchmark"), which tracks Front Quarter and Second Quarter mini MSCI Emerging Markets Index futures, plus the interest revenue earned on the collateralised amount.

For example, if the Benchmark rises by 1% over a day, then the ETP will rise by 3%. However if the Benchmark falls by 1% over a day, then the ETP will fall by 3%. In both cases excluding fees and funding costs.
